The DBM-DOF-DENR-DOE Joint Circular No. 2006-1 dated 13 February 2006, entitled "Revised Guidelines and Procedures on the Release of the Share of Local Government Units in the Proceeds from the Development and Utilization of National Wealth" governs requirements and procedures in the submission of the share of LGUs to the Department of Budget and Management. A memorandum was issued on August 9, 2006 signed by then OIC Undersecretary for Management and Technical Services entitled "Revised Procedures and Forms RE LGUs Share in the Proceeds from the Development and Utilization of National Wealth" implementing the circular and prescribing the forms to be used and the procedures to be followed.

Related to this, Dir. Carmencita N. Delantar of Budget and Management Bureau G in her letter dated 18 August 2013 (copy attached) informed us on the procedures to be adopted that DENR Central Office shall endorse to the Bureau of Treasury (formerly to DBM) the 40% LGU shares. This is in pursuant to Special Provision No. 2 of Section XXXVI.A - Allocation to Local Government Units of FY 2013 General Appropriations Act.

Consistent with the DBM-DOF-DENR-DOE Joint Circular No. 2006-1, attached are the revised internal procedures and forms to be used in the recording, consolidation and submission or reports to the BTr, to wit:
